Highway:

- The Town Highway Superintendent submitted a written report on activities for March 2013 and highlighted fuel usage, a plowing / sanding update, and work at the harbor.
- Raymond Schuster moved and David Spann seconded a motion to approve the Highway Superintendent's recommendations on acceptance of 2013 annual bids for fuels and materials. Unanimously approved.

Code Enforcement:

- The Code Enforcement Officer submitted a written report highlighting that 9 permits were issued in the Town for March 2013, and the fact that Mazza Distillery plans to be open for Memorial Day.

Barcelona Harbor: The Pier will soon open for the 2013 season (depending on weather). The new light posts for the pier have arrived and will be installed in April by the Town and Village.

RESOLVED, subject to the approval of counsel as to its final form, the Supervisor is hereby authorized to execute the "Construction & Demolition Waste Addendum" to the current Chautauqua County Shared Highway Services Agreement, making the Town eligible to receive an annual credit for tipping fees of 80 tons of construction and demolition waste at the Chautauqua County landfill.
