## MEMO

**RE:** Monthly Fire Department Report for November, 2016  
**DATE:** December 1, 2016

Members of the Fire Department of Westfield responded to a total of 46 calls during the month of November. The breakdown is as follows:

- **Six Fire Calls:**
  - two in the Village – vehicle fire next to the railroad tracks behind Clark Street; and reported fire outside of the building at Calarco's Restaurant, 15 Market Street;
  - three in the Town – report of unknown type of fire spreading at East Central Avenue and Shore Drive in Forest Park (controlled leaf burning); passerby reported a leaf fire out of control at 6644 Westfield-Sherman Road (controlled burn); and an RV fire at 7233 Route 5; and
  - one on the NYS Thruway – vehicle fire at mile marker 478 westbound.
- **One MVA:** NYS Thruway – car versus deer at mile marker 479 westbound.
- **37 EMS Calls:** 24 in the Village; six in the Town; and seven at Absolut Care.
- **Two Service Calls:** large tree down on a house and vehicles at 21 Brewer Place; and tree and wires down on the road at 7250 Route 5.
