RE: Monthly Fire Department Report for February
DATE: March 3, 2018

Members of the Fire Department of Westfield responded to a total of 54 calls during the month of February. The breakdown is as follows:

- **Two MVA's:** both on the NYS Thruway – one with unknown personal injury at mile marker 485.7 westbound; and a three-vehicle accident at mile marker 476.3 eastbound.
- **46 EMS Calls:** 21 in the Village; nine in the Town; and 16 at Absolut Care.
- **Four Service Calls:** a transport to Millcreek, PA; a local transport from Westfield Memorial Hospital to Absolut Care; a power pole sparking at 7251 Route 20; and a transport to Brooks Memorial Hospital.
- **Two False Alarms:** a fire alarm activation due to burnt toast at 7680 Route 5; and a smoke detector sounding, which Westfield Police found in a dumpster, at 69 South Portage Street.
