RESOLUTION #10-2023/MAIN STREET GRANT CHAUT. HOUSING REHABILITATION CORPORATION (CHRIC)

The board made a motion to approve the following Resolution by Trustee Einach, seconded by Trustee Maras and was carried unanimously.

Resolution by the Village Board of Trustees approving and endorsing Chautauqua Housing Rehabilitation Corporation, (CHRIC), in its application to NYS Homes and Community Renewal for funding under the New York Main Street Program.

WHEREAS, the Chautauqua Housing Rehabilitation Corporation, (CHRIC), desires to apply for \$360,000 in financial assistance through the 2023, Consolidated Funding Application (CFA) under the New York Main Street Program; and

WHEREAS, the application proposes funding to assist property owners to complete building renovations to downtown "main street" buildings on Main Street between North Portage Street to Market Street; and

WHEREAS, the proposed funding will contribute to ongoing community revitalization efforts; and WHEREAS, the grant application requires that the applicant obtain the approval and endorsement of the governing body of the municipality in which the project will be located. NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Westfield approves and endorses the 2023 New York Main Street Grant for assistance prepared and to be submitted by Chautauqua Housing Rehabilitation Corporation, (CHRIC). WHEREAS, the New York State Department of Environmental Conservation (DEC) provides a competitive statewide grant funding for wastewater treatment improvements to municipal wastewater systems and the Village of Westfield considers this project a priority; and NOW THEREFORE BE IT RESOLVED, the Village Board, on behalf of the Village, identifies the Village Mayor as the authorized representative for the project, able to execute necessary documents relative to and as required for this application; and

BE IT FURTHER RESOLVED, the Village Board does hereby accept that they shall provide at least a 25% match of the total of any grant funding awarded as a local match in the form of in-kind services or cash contributions hereby appropriated and obligated from the SRF Financing; and BE IT FURTHER RESOLVED, the Village Board approves MRB Group to prepare and submit the WQIP grant application within the CFA portal; and

BE IT FURTHER RESOLVED, that the Village of Westfield, recognizes and fully supports the submission of the CFA for a Wastewater Treatment Improvement Grant by MRB Group on behalf of the Village for improvements to the Wastewater Treatment Plant and to address Inflow and Infiltration within the collection system.
